

Tribute to Dr. John F. Maras, DO

In 2002, Dr. Maras wrote, "I consider myself one of the lucky cancer victims. I was diagnosed with prostate cancer in 1994. I had a PSA of 10.5 and a Gleason score of 6-7. These numbers are why I consider myself to be a lucky cancer victim. I believe that if I would have done traditional prostate cancer treatment, I would not be alive today, just as many who followed such doctors' orders are no longer living...My doctors gave me 2-2½ years to live..."¹

Since 1995, Dr. Maras was living an active life and doing quite well until late December 2004 when he suffered a surprise, major physical assault by an irrational man. Dr. Maras broke/cracked a few ribs, broke his pelvis, suffered multiple facial injuries from his fall, and also sustained other significant physical damage.² Between the significant physical injuries from being seriously assaulted, stress from the lawsuit against his attacker, massive stress from four unwarranted and intimidation-aimed FDA raids over the past 4 years, stress from several moves, and countless emotionally-draining phone and email consultations, Dr. Maras' health finally took a turn for the worse. Dr. Maras experienced a tremendous healing crisis load from his significant physical injuries and began suffering from chronic inflammation, pain and depression. His health condition finally became all consuming and completely out-of-control. Dr. Maras could not seem to recuperate and defeat his condition and win wellness back for a 2nd time. Consequently, it is with much sadness I announce that Dr. Maras died on June 9, 2006, at the age of 68.

I feel so blessed to have known and worked with Dr. Maras and to be part of the company that he and his wife Barbara—formerly a Registered Nurse (R.N.) for 41 years—worked so hard to create. He is one of few men I have ever met that exemplified amazing humility, kindness and willingness to help so many people. In 2004, Dr. Maras wrote, "I have consulted with 30,000 more patients and families over the past two years bringing my total number of email and telephone consultations to over 105,000 in eight years. The internet moves rapidly."³

Dr. Maras' wellness crusade all began after his doctors gave him the "death sentence". Dr. Maras wrote, "My doctors gave me 2-2 ½ years to live. My wife, Barbara and I decided to move to Florida from Pennsylvania where I had practiced medicine, neurology and psychiatry for nearly 25 years. We thought we 'may as well be warm if I only had that long to live.' When I arrived in Florida in my unna boots on both lower legs (unna boots are soft casts impregnated with zinc oxide ointment) to heal the ulcers on my legs, I became interested in searching the internet to find non-toxic treatment for my prostate cancer and circulation problems. I never had much faith in traditional treatment of prostate cancer, and I was aware that due to my other health challenges, I probably would not survive the traditional treatments including surgery, radiation, and hormone therapy. My initial research lead me to explore saw palmetto and horse chestnut extracts. I also did a lot of research regarding OPC's and shark liver oil products. The combinations of research lead me to my original program in 1995 which included apricot kernels, OPC's, shark liver oil, saw palmetto, and enzymes. This combination worked quite well for me, although my PSA drove me nuts because it would go up and down! A friend whom I had met while doing research on the internet, Dan Gesch, said I should consider doing a web page on the internet to 'tell my story.'"⁴

Dr. Maras never stopped looking for other products which could help more people win their battle against disease. Dr. Maras wrote, "Meanwhile, a patient had sent me literature about a product called Cantron...My PSA was still fluctuating and I was looking for something to add to my prostate program. A breast cancer patient I had called regarding her testimony, said that she had heard that Cantron 'was effective in treating brain cancer.' I had been trained in neurology and I had a particular interest in brain cancer and nerve function disorders. She gave me the telephone number of Ollie Blezinski of the H.O.P.E. (Humanitarian Organization for the Promotion of Entelev) Foundation in Warren, Michigan. I called Ollie, who is an organic farmer and a walking encyclopedia regarding nutritional healing. After several long telephone conversations, I added Cantron to my cancer Wellness Program in July 1997. I remember during one of my first conversations with Ollie, she said, 'You know John, you doctors don't know diddly about nutrition.' I said, 'Ollie, I have good news and bad news. The good news is that I agree - doctors don't know diddly about nutrition. The bad news is - you are going to have to teach me!' We have been good friends ever since."⁵ The H.O.P.E. group first helped Dr. Maras and his wife Barbara in 1997, and Dr. John and Barbara Maras have been returning the favor ever since then with their Nu-Gen Nutrition company and products, support meeting presentations, informative websites, email and telephone consultations, and two editions of the Rational Wellness Therapy (RWT) book. Dr. Maras coined the new health concept or 'model,' called Rational

Wellness Therapy (RWT). RWT treats the whole nature of the individual through supplementation, diet, exercise, meditation, prayer, etc.⁶ Their RWT books were written to provide the average individual with quick answers to their most frequently asked questions.

Andy replied, "We have been able to help sick people with products and information that otherwise would not be publicly available." Dr. Maras then said that he had previously asked Barbara shortly after the raid, "Why are we doing all this? We are retired and don't need all this pressure and harassment." Barbara then replied, "John, you know that if you don't do it, no one else will." Dr. Maras agreed and never stopped in spite of tremendous adversity, to help people to the maximum he was capable, as long as he physically could.⁸
